Connecting the Dots: Understanding Volunteer Motivations through the Lens of John Paul II's Message

Abstract

This study explores the motivations driving individuals to engage in volunteer activities, inspired by John Paul II's message for the UN Year of Volunteer Work (2001). Using structured and open-ended questionnaires, the research examines respondents' reasons for volunteering across six themes: Compassion and Empathy, Sense of Duty, Positive Impact and Fulfillment, Personal Growth and Awareness, Interconnectedness, and Spirituality and Faith. Thematic analysis (Aronson) categorizes responses, revealing that Altruistic Purpose and Collective Well-being are the primary motivators. Participants express a strong desire to positively impact others' lives and contribute to societal good. Satisfaction with volunteering is assessed through Satisfaction Rate Calculations (SmartSurvey™, 2021), which yield a high overall Satisfaction Rate of 85.33%, reflecting the rewarding nature of such activities. By linking motivations to actions, the study provides valuable insights for fostering sustained volunteer engagement. These findings can guide organizations in creating effective programs that inspire long-term commitment to volunteer work, ensuring that volunteerism continues to thrive as a powerful force for societal benefit.

INTRODUCTION

Pope John Paul II today remains a towering figure in the history of the Catholic Church, revered for his profound spiritual insights, tireless advocacy for social justice, and unwavering commitment to the welfare of humanity. Though he passed away in 2005, his teachings, writings, and messages continue to resonate with people across the globe. Today, he is remembered as Saint John Paul II, having been canonized by the Catholic Church in recognition of his exemplary life and contributions to the faith. As a saint, he serves as a spiritual guide and inspiration for millions of Catholics and non-Catholics alike, symbolizing the transformative power of love, compassion, and service to others. His legacy endures as a beacon of hope and guidance for those striving to make a positive difference in the world. His message continues to inspire individuals and communities to embrace the values of love, generosity, and solidarity, echoing his timeless message of faith, hope, and charity. "Through love of God and love of the brethren, Christianity releases all of its liberating and salvific power" (John Paul II, 2001, #2).

His message for the UN Year of Volunteer Work reflects his deep understanding of the human condition and his call to action for individuals to embrace their innate capacity for compassion and selfless service. Through his words, he emphasizes the universal value of volunteerism to promote human dignity, foster solidarity, and build a more just and compassionate society. "For this reason, volunteer work is a special factor that contributes to humanization. Thanks to the many forms of solidarity and of service that they promote and make concrete, volunteer workers make society more attentive to the dignity of the human person and his/her many expectations" (John Paul II, 2001, #1).

The enduring influence of Saint John Paul II as a proponent of volunteerism is underscored by his spiritual teachings and unwavering commitment to social justice. His canonization and continued legacy as a spiritual leader exemplify this influence, where he fervently advocates for individuals to embody compassion and selfless service towards others.

Framework

The Message of John Paul II for the UN Year of Volunteer Work was delivered in 2001. During this time, there was a growing recognition globally of the invaluable contributions made by volunteers in addressing various societal challenges. The late 20th and early 21st centuries witnessed an increasing emphasis on humanitarian efforts, social justice movements, and community engagement. The United Nations, in particular, had been advocating for the promotion of volunteerism as a means to foster development, peace, and social cohesion.

John Paul II's message on volunteer work aligns with the broader global movement towards recognizing and promoting volunteerism as a fundamental aspect of civic engagement and social responsibility. The rationale behind the message stems from the understanding that volunteerism is deeply rooted in human compassion, transcending cultural, religious, and geographical boundaries. Moreover, in an era marked by complex social challenges, such as poverty, inequality, and conflict, volunteerism emerges as a powerful tool for addressing these issues locally and globally.

The primary purpose of John Paul II's message is to affirm the significance of

volunteer work and to inspire individuals and communities to engage in acts of service for the betterment of society (John Paul II, 2001, #3). By delivering this message, the Pope aims to highlight volunteerism's spiritual and humanitarian dimensions, emphasizing its transformative potential in fostering solidarity, compassion, and social justice. Additionally, the message seeks to encourage collaboration between public institutions, civil society organizations, and volunteers to create supportive environments for volunteer efforts and recognize volunteers' contributions. This idea of transcending boundaries aligns with the broader intellectual discourse on social engagement. For instance, Karna (2019) highlights that competencies like analytical skills and a deep understanding of religious discourse are essential for individuals involved in volunteerism to explore the complexities of modern social issues. These intellectual skills complement the spiritual and humanitarian aspects of service that John Paul II emphasized.

The Message of John Paul II for the UN Year of Volunteer Work serves as a comprehensive call to action, aiming to raise awareness about the vital role of volunteerism in society as a manifestation of human compassion and a driver of positive social change. By drawing upon the examples of Christ, Mary, and historical figures, the message inspires individuals to actively engage in volunteer work, promoting values such as love, service, solidarity, and outreach as essential tools in addressing contemporary societal challenges. Moreover, it advocates for the recognition and support of volunteers by public institutions, acknowledging their crucial contribution to filling gaps in service delivery and complementing government efforts. Emphasizing the spiritual dimensions of volunteerism, the message encourages volunteers to persevere in their service and deepen their understanding of charity and compassion, fostering both individual and collective spiritual growth. "It is not enough to help whoever is in material difficulty; it is necessary at the same time to respond to his thirst for values and personal spiritual solutions" (John Paul II, 2001. #3). John Paul II also recognized the importance of addressing failure and perseverance in volunteerism. Harford (2011) echoes this sentiment by underscoring that failure often serves as a precursor to success, a reminder to volunteers to persist despite setbacks. The Pope's call for spiritual growth and resilience in volunteer work resonates with the idea that service benefits society and contributes to personal development and understanding of deeper values.

Moreover, the message from John Paul II can be contextualized within the Church's broader approach to social engagement, as influenced by the Second Vatican Council. The council's call for Ecclesia semper reformanda est ("the church must always be reformed") is a key aspect of the Church's ongoing mission to remain responsive to societal changes (Wilbricht, 2018). This is further emphasized by Nickless (2022), who states that the Church is called to live by constant reformation in an ever-evolving world, thereby extending its mission to address new challenges through acts of service.

John Paul II's message also reflects the principle of Aggiornamento, or the Church's need to be up to date with the needs of society (Butler, 2020). This principle reinforces the Pope's vision that volunteer work is not merely a religious or charitable endeavor but a critical response to contemporary issues. In a similar vein, Elder and Paul (2013) highlight the importance of intellectual standards when assessing thinking structures, which volunteers must adopt to approach service with clarity and a critical understanding of the issues at hand.

The Six Key Themes Within John Paul II's Message

Compassion and Empathy: "At the end of the year that the United Nations dedicated to Volunteer work, I wish to express my heartfelt appreciation for your constant dedication...you represent for children, the elderly, the sick, people in difficulty, refugees and the persecuted a ray of hope" (John Paul II, 2001, #1). Here, John Paul II acknowledges the compassionate dedication of volunteers who extend help to various marginalized groups, recognizing their struggles and offering hope. This illustrates how compassion and empathy are driving forces behind volunteering, as volunteers seek to alleviate the suffering of others.

Sense of Duty: "Dear Volunteers! What makes a volunteer dedicate his/her life to others? It is a law of existence" (John Paul II, 2001, #1). John Paul II implies that the dedication of volunteers to serving others is inherent in human nature, suggesting a sense of duty towards others as a fundamental aspect of human existence. This aligns with the concept of duty towards marginalized groups, emphasizing the responsibility to extend a helping hand.

Positive Impact and Fulfilment: "[V]olunteer work is a special factor that contributes to humanization...volunteers come to realize that, only if one loves and gives himself to others, does the human creature reach perfect fulfillment" (John Paul II, 2001, #1). John Paul II highlights how volunteer work contributes to the humanization of society and emphasizes that volunteers find fulfillment in giving themselves to others. This illustrates how volunteering is perceived as a source of personal fulfillment and accomplishment, as volunteers make a positive impact on the lives of others.

Personal Growth and Awareness: "[V]olunteer work is called to be a school of life, especially for young people, contributing to educating them in a culture of solidarity and outreach, open to the free gift of self" (John Paul II, 2001, #3). John Paul II describes volunteer work as a school of life that contributes to the education of individuals in solidarity and outreach. This suggests that engaging in volunteer work fosters personal growth, broadens understanding, and boosts self-confidence, aligning with the theme of personal growth and awareness.

Interconnectedness: "[V]olunteer work is called to be a school of life, especially for young people, contributing to educating them in a culture of solidarity and outreach, open to the free gift of self" (John Paul II, 2001, #3). John Paul II's mention of volunteer work as a school of life suggests that it fosters a culture of solidarity and outreach, emphasizing interconnectedness. This aligns with the theme of interconnectedness, as volunteerism promotes the understanding of the inherent connection between all beings.

Spirituality and Faith: "Charity represents the most eloquent form of evangelization...Through volunteer work, the Christian becomes a witness of this divine charity..." (John Paul II, 2001, #2). John Paul II emphasizes the spiritual dimension of volunteer work, describing it as a form of evangelization and divine charity. This highlights how volunteerism is aligned with spiritual teachings and reflects one's commitment to compassion and support, resonating with the theme of spirituality and faith.

The Six Key Themes in Embracing Ecological Spirituality

Based on the qualitative input provided by respondents in the study titled

"Embracing Ecological Spirituality: An Exploration of Volunteer Motivations" (Ingles, 2023), six recurring themes become evident. Volunteers, guided by Compassion and Empathy, recognize their responsibility to positively impact others' lives, considering these qualities essential for effective service. This emphasis on service aligns with the core tenets of volunteerism, which revolves around selflessly offering one's time and efforts for the betterment of others and the community (Wilson, 2012). They express a consistent Sense of Duty towards marginalized groups, aligning their actions with aspirations for a more inclusive society. Similarly, volunteerism fosters compassion by encouraging individuals to extend their care and support to those in need, promoting social justice and equity (Wilson, 2012). In 2015, Pope Francis declared that environmental education "needs educators capable of developing an ethics of ecology, and helping people, through effective pedagogy, to grow in solidarity, responsibility and compassionate care" (LS #210). This call further emphasizes the importance of nurturing empathy and responsibility toward both society and the environment.

Volunteering brings Positive Impact and Fulfilment through assisting others and fostering positive change. Volunteerism actively seeks to improve the lives of individuals and communities, addressing social, environmental, and humanitarian needs to enhance overall well-being (Wilson, 2012). Additionally, it serves as a catalyst for Personal Growth and Awareness, offering new perspectives and enhancing understanding of diverse communities, resulting in collaborative efforts for societal improvement. It also recognizes the interconnection between individuals and communities, highlighting the importance of collective action and collaboration for the betterment of society (Wilson, 2012).

Volunteers acknowledge the Interconnectedness of humanity, viewing their service as a reflection of this shared human experience, guiding their beliefs and actions towards collective well-being. Volunteerism encourages gratitude by providing opportunities for individuals to witness and appreciate the impact of their actions, fostering a sense of appreciation for the opportunity to serve and make a positive difference in the lives of others (Wilson, 2012). Furthermore, volunteer work reflects a commitment to Spirituality and Faith, akin to spiritual teachings, providing an opportunity to align actions with faith and contribute to the greater good.

The writer employs these six key themes in this present study as criteria for the respondents to assess their overall satisfaction, with the aim of understanding individuals' motivations for engaging in volunteer work. The letter titled "Message of John Paul II for UN Year of Volunteer Work" (John Paul II, 2001) addresses the same six themes: Compassion and Empathy, Sense of Duty, Positive Impact and Fulfilment, Personal Growth and Awareness, Interconnectedness, as well as Spirituality and Faith. The relationship between John Paul II's message and the key themes identified in the study "Embracing Ecological Spirituality" provides profound insights into the motivations driving volunteerism and its wider societal implications. Based on these themes, the Research Questionnaire for the present study was developed.

The findings inform the development of a research questionnaire aimed at deepening our understanding of volunteer motivations and their societal impact. They underscore the significance of John Paul II's message in inspiring individuals to engage in volunteer work, thus fostering a culture of compassion and solidarity that enhances the welfare of humanity.

John Paul II's Message aligns with global efforts recognizing volunteerism's role in fostering development, peace, and social cohesion. He highlights volunteerism as a response to complex societal challenges, emphasizing its spiritual and humanitarian dimensions. Six key themes underpin his message. This framework connects spiritual principles with the practical benefits and motivations of volunteerism, offering insights into its societal and personal impact.

Problem

John Paul II's message for the UN Year of Volunteer Work (2001) highlights the significance of volunteerism in fostering solidarity, compassion, and social justice, emphasizing collaboration between institutions and volunteers. His message identifies six central themes: Compassion and Empathy, Sense of Duty, Positive Impact and Fulfilment, Personal Growth and Awareness, Interconnectedness, and Spirituality and Faith. These align closely with a study on "Embracing Ecological Spirituality," which notes similar motivations among volunteers, such as compassion, duty, interconnectedness, and personal growth (Ingles, 2023).

This research seeks to bridge John Paul II's moral and spiritual framework with contemporary insights into volunteer motivations, particularly their societal impact. By exploring the six themes through a mixed-methods approach—combining quantitative surveys with qualitative responses—the study aims to uncover patterns in volunteer experiences, motivations, and satisfaction levels. Understanding these dynamics will help develop strategies to enhance volunteer engagement and contribute to social cohesion and community development.

The key research question is: What connects the dots between individuals' motivations for volunteer work with their satisfaction levels, as reflected in the six themes articulated in John Paul II's message on volunteerism?

METHODOLOGY

Explanatory Sequential Mixed Methods

This study adopts an Explanatory Sequential Mixed Methods design to thoroughly explore the motivations behind individuals' participation in volunteer work and assess their satisfaction levels. This approach integrates quantitative and qualitative methodologies to provide a comprehensive understanding of the factors influencing volunteer engagement and satisfaction. The study follows a two-phase process: initial quantitative data collection followed by qualitative data collection to enrich and interpret the quantitative findings.

The research design leverages both quantitative and qualitative methods, starting with the collection of quantitative data through structured research questionnaires. This phase is followed by qualitative data collection using openended questions to gain deeper insights and context that help explain the initial findings. This sequential approach allows the study to capture a broad overview through quantitative analysis and delve deeper into the underlying themes through qualitative analysis.

Participants are selected through purposive sampling to ensure a representative group of individuals actively engaged in volunteer work. This purposeful approach guarantees that respondents possess firsthand experience and provides insights into

diverse demographic factors such as age, gender, and types of volunteer activities.

The structured questionnaire is divided into twelve sections, each aligned with a specific theme related to volunteer motivations. Closed-ended questions capture respondents' agreement or satisfaction levels, facilitating quantitative analysis, while open-ended questions are included to capture more nuanced perspectives. This dual approach ensures that quantitative data provides a general overview, while qualitative responses add depth and context to the findings.

The quantitative data are analyzed using statistical methods, employing a 100% to 0% rating scale for responses that reflect the participants' degree of agreement or resonance with each statement. This provides a clear, numerical representation of respondents' motivations and satisfaction levels. The Satisfaction Rate metric, derived from basic statistics (SmartSurveyTM, 2021), calculates an overall measure of respondents' satisfaction with their volunteer experiences. To complement the quantitative findings, qualitative data are analyzed using thematic analysis based on Aronson's method, categorizing and interpreting responses from open-ended questions to identify emergent themes that provide context and depth to the quantitative results.

The interpretation of findings situates the data within the study's research objectives. Quantitative results are represented through tables and charts, providing a clear, data-driven overview of volunteer motivations and satisfaction. Qualitative findings are reported through thematic narratives that contextualize the quantitative results, allowing for a richer understanding of the respondents' experiences. The implications for theory and practice are discussed, and the study concludes with recommendations for future research aimed at enhancing volunteer engagement strategies.

Participants

During the second term of the academic year 2023-2024 in De La Salle – College of Saint Benilde, Manila, Philippines (DLS-CSB), the writer taught four sections in the fully online modality, comprising a total of 178 students. Initially, 178 survey questionnaires were emailed to these students as sample respondents, yielding responses from only 101 students. The analysis focused on the feedback provided by these 101 students currently enrolled in Religious Experience and Spirituality (REEXECO) courses at DLS-CSB. In this online setting, students attend classes once a week, engaging with digital learning materials, resources, and activities through an online platform or learning management system. This component encompasses pre-recorded lectures, readings, multimedia content, interactive modules, quizzes, discussion forums, and assignments, allowing students the flexibility to participate at their own pace and convenience outside of scheduled in-person classes.

Table 1 indicates that the majority of REEXECO students fall within the age range of 16 to 20, comprising 86.1% of the population. Meanwhile, 13.9% of students

are aged between 21 and 25.

This Table 2 presents the gender distribution among students in the REEXECO population based on the provided data. It displays the number of students and their corresponding percentages according to self-classification. The data reveals that among REEXECO students, 49.5% identify as Female, 40.6% as Male, 7.9% prefer not to specify their gender, and 2% identify as Non-binary.

Data Collection Methods

Quantitative data are collected through self-administered structured research questionnaires distributed online. Qualitative data are gathered through open-ended questions embedded within the questionnaire, allowing respondents to provide detailed reflections on their motivations and experiences. For a systematic method of collecting and measuring data collected, this paper used Google Forms questionnaire survey. Google Forms provides a free and fast way to create an online survey. The survey data is then automatically saved into a Google Sheets spreadsheet and then turn your data into charts and other visualizations in seconds (Murphy, 2017). "Answers obtained through closed-ended questions with multiple choice answer options are analyzed using quantitative methods and they may involve pie-charts, bar-charts, and percentages" (Business Research Methodology, 2021).

Research Questionnaire

The Research Questionnaire comprises twelve sections, each addressing specific themes related to motivations for engaging in volunteer work. The items are numbered sequentially within each theme for clarity and consistency.

The questionnaire begins by addressing Compassion and Empathy, with items focusing on the importance of these qualities in driving the decision to volunteer (items 1.1 and 1.2). Subsequent items (2.1 and 2.2) examine the personal experiences where compassion for others inspires volunteering and assess satisfaction with those instances.

The subsequent sections maintain a consistent pattern, following a similar structure, addressing Sense of Duty, Positive Impact and Fulfilment, Personal Growth and Awareness, Interconnectedness, and Spirituality and Faith, respectively. Each theme is investigated through two pairs of items. One item prompts respondents to offer descriptions or reflections, while the other asks them to rate their satisfaction or belief using a five-category rating scale: Excellent (100%), representing a high level of satisfaction (76-100); Good (75%), indicating a moderate level of satisfaction (51-75); Fair (50%), signifying a fair level of satisfaction (26-50); Poor (25%), reflecting a low level of satisfaction (1-25); and Not Applicable (0%).

For instance, items under the Sense of Duty theme (items 3.1, 3.2, 4.1, and 4.2) inquire about respondents' sense of duty towards their community, its influence

on their decision to volunteer, and their satisfaction with it. Similarly, items under other themes explore different facets of individuals' motivations, experiences, and satisfaction related to volunteering.

The questionnaire is designed to comprehensively cover various dimensions of motivation, including emotional, moral, and spiritual aspects. By addressing these diverse themes and criteria, the Research Questionnaire aims to provide a holistic understanding of individuals' motivations for engaging in volunteer work. It allows respondents to reflect on their experiences, values, and beliefs, and to assess their satisfaction with various aspects of their volunteer engagement. Through this comprehensive approach, the Research Questionnaire is expected to yield valuable insights into the complex motivations underlying volunteerism.

Ethical Consideration and Data Privacy Statement

This study adheres to strict ethical guidelines to ensure the rights and dignity of all participants are respected. Prior to data collection, participants were fully informed about the purpose, nature, and scope of the research, ensuring that their involvement was entirely voluntary. Informed consent was obtained in writing, where respondents were briefed on their right to withdraw from the study at any time without any negative consequences.

Additionally, the research design incorporated measures to minimize any psychological, emotional, or social risks associated with discussing personal motivations for volunteering. Participants were encouraged to share only what they felt comfortable disclosing and assured that their responses would be handled with sensitivity and confidentiality.

In compliance with data privacy laws and institutional policies, all personal data gathered during the research was anonymized to protect participants' identities. The study collected minimal identifiable information, and any potentially identifying details were removed or generalized. Data was securely stored in password-protected files, with access limited to the primary researcher and authorized personnel. Upon completion of the research, data will be retained for a defined period to allow for future analysis, after which it will be securely deleted.

This research complies with the Data Privacy Act of 2012 (Republic Act No. 10173) of the Philippines, ensuring that all data collected was processed lawfully, fairly, and transparently.

RESULTS

Adato (2011) claims that "while surveys provide generalizable findings on what outcomes or impacts have or have not occurred, qualitative methods are better able to identify the underlying explanations for these outcomes and impacts, and therefore enable more effective responses." She asserts that, "when used together, quantitative and qualitative approaches provide more coherent, reliable, and useful conclusions than do each on their own" (Adato, 2011).

By employing a blend of quantitative and qualitative methodologies, this study endeavors to capture a comprehensive, holistic, and contextual picture. It aims to connect the dots between the motivations driving individuals towards volunteerism and their corresponding levels of satisfaction in engaging with volunteer activities.

Drawing inspiration from John Paul II's insights on volunteerism, the research examines six themes that embody the central aspects of volunteerism: Compassion and Empathy, Sense of Duty, Positive Impact and Fulfillment, Personal Growth and Awareness, Interconnectedness, and Spirituality and Faith. These themes serve as guiding principles, highlighting the intricate connection between volunteer engagement and its significant impact on both society and individuals.

In interpreting students' qualitative response as text, we cannot separate ourselves from the meaning of the text. The reader belongs to the text (or social situation) that he or she is reading (or experiencing). Understanding is always an interpretation, and an interpretation is always specific, an application (van Manen 1990, p. 180 as cited in Warnes, 2015). There are five (5) steps of thematic analysis based on the work of Aronson, but this writer only adapted the first three (3) steps and the last (5th) step for this paper, with some modifications (Aronson, 1995, par. 1-9 as cited in Ingles, 2017, p. 106).

Step 1 Collecting all the data: The writer collected and secured the students' qualitative responses to the unstructured questionnaire comprises twelve sections, each dedicated to specific themes related to volunteer motivations. Open-ended questions are utilized to encourage detailed responses for deeper insights and then each student's response is assigned with a unique ID Label. The hashtags and the numbers after the hashtags are the unique ID labels of the students' comment entries.

Step 2 Identifying patterns of experiences: On the basis of all students' qualitative responses to the Questions 1.1 to 12.1, the students are guided to reflect on their motivations across six key themes: Compassion and Empathy, Sense of Duty, Positive Impact and Fulfilment, Personal Growth and Awareness, Interconnectedness, and Spirituality and Faith, and on the other hand, the writer identified students' qualitative responses to each of the questions and relate their responses to the classified patterns, then the identified patterns are expounded on. "All of the talk that fits under the specific pattern is identified and placed with the corresponding pattern" (Aronson, 1995, par. 6 as cited in Ingles, 2017, p.106).

Step 3 Cataloguing related patterns into Themes and Sub-Themes: On the basis of all students' qualitative responses, the writer listed the patterns of their comment entries by cataloguing them into themes and sub-themes. Themes are "defined as units derived from patterns such as conversation topics, vocabulary, recurring activities, meanings, feelings, or folk sayings and proverbs" (Aronson, 1995, par. 7 as cited in Ingles, 2017). "Themes are identified by bringing together components or fragments of ideas or experiences, which often are meaningless when viewed alone." "The themes that emerge from the informants' stories are pieced together to form a comprehensive picture of their collective experience. "The coherence of ideas rests with the analyst [writer] who has rigorously studied how different ideas or components fit together in a meaningful way when linked together" (Aronson, 1995, par. 7 as cited in Ingles, 2017, p. 107).

Step 4 Telling the whole story: The final task is to "build a valid argument for choosing the themes". By making inferences from all the students' qualitative responses, Themes and Sub-Themes are formulated into theme-statements to develop a story line. A story line refers specifically to the narrative thread or strand shared by a student which when woven by the writer together with the other threads or strands they make a whole story. (Aronson, 1995, par. 9 as cited in Ingles, 2017, p.

107).

Personal anecdotes, such as firsthand experiences with natural disasters or active involvement in community shelters, vividly illustrate how compassion and empathy propel individuals toward volunteer engagement.

The study unveils a deep-rooted sense of duty and privilege among participants, compelling them to contribute positively to their communities and extend support to those in need. This sense of duty acts as a significant determinant in individuals' decisions to volunteer, guided by an unwavering commitment to social responsibility and collective well-being. Importantly, volunteering not only fulfills individuals personally but also empowers them to effect tangible change, acquire new skills, and nurture meaningful connections. Many volunteers recount impactful experiences, such as aiding in disaster relief efforts or spearheading charitable initiatives, which leave lasting impressions of fulfillment and satisfaction.

The study discerns several central themes across different categories, including personal growth and awareness, skill development, and societal impact. Through volunteering, individuals undergo deep personal transformations, gaining insightful understanding into gratitude, empathy, and purpose, while also attuning themselves to their own privilege. This heightened awareness of interconnectedness acts as a potent motivator, inspiring volunteers to actively contribute towards creating a more compassionate and inclusive world. Additionally, faith and spirituality emerge as influential factors, imbuing volunteering with a sense of sacred duty and emphasizing alignment with fundamental values.

The study underscores the transformative potential of volunteering, elucidating its capacity to foster empathy, stimulate personal growth, and strengthen bonds within communities. It serves as a compelling reminder of the shared values and beliefs that unite individuals in their pursuit of collective well-being and societal harmony.

This strong interdependency between these motivations and their associated satisfaction levels highlights the various themes that influence volunteer engagement.

Personal Fulfillment and Sense of Accomplishment: This motivation ranks highest in terms of satisfaction among surveyed students with an Excellent rating and a satisfaction rate of 90.10%. Volunteers who feel a sense of personal fulfillment and accomplishment are more likely to remain engaged in their activities. Understanding this high level of satisfaction indicates that strategies emphasizing personal growth, recognition of achievements, and opportunities for meaningful contributions could be effective in sustaining volunteer engagement.

Importance of Compassion and Empathy: Similarly, a high level of satisfaction with the importance of compassion and empathy suggests that volunteers value the opportunity to make a positive impact on others' lives. This motivation also received an Excellent rating with a satisfaction rate of 89.85%. Strategies that foster a supportive and empathetic environment, provide training in interpersonal skills, and highlight the significance of compassion in community service are likely to enhance volunteer engagement.

Personal Growth and Understanding of Communities: Volunteers expressing satisfaction with personal growth and understanding of communities indicate a desire for learning and deeper engagement with the issues affecting their communities. This motivation received an Excellent rating with a satisfaction rate of 88.12%. Strategies that offer educational programs, cultural immersion experiences, and opportunities for skill development aligned with community needs can enhance volunteer satisfaction and commitment.

DISCUSSION

This study has provided comprehensive insights into the driving forces behind volunteerism and their direct influence on volunteer satisfaction. Employing a dual approach of qualitative and quantitative methodologies, this study uncovered a spectrum of intrinsic motivations driving individuals to engage in volunteer work, including compassion, empathy, duty, personal growth, interconnectedness, spirituality, and faith. These motivations, deeply rooted in a genuine sense of community responsibility, not only underscore the altruistic nature of volunteerism but also serve as crucial factors in determining volunteers' overall satisfaction levels.

The qualitative analysis presented a strong correlation between these intrinsic motivations and volunteer satisfaction, particularly highlighting the pronounced fulfillment experienced by those driven by compassion, empathy, and duty. Moreover, aligning volunteer activities with the overarching themes articulated in John Paul II's message emerged as a potent strategy for augmenting volunteer fulfillment and wellbeing.

The quantitative role of this study reinforced these qualitative findings, shedding light on the intricate interplay between various motivational factors and satisfaction levels. Notably, intrinsic motivators such as personal fulfillment, compassion, and personal growth emerged as robust predictors of volunteer satisfaction, alongside external influences like faith and spirituality.

The findings of this study underscore the nuanced and multifaceted nature of volunteer motivations, emphasizing the importance of acknowledging and leveraging these intrinsic drivers to enhance volunteer satisfaction and retention. By integrating the principles outlined in John Paul II's message and fostering environments that nurture these motivations, organizations can cultivate a more engaged and fulfilled volunteer community, ultimately amplifying the positive impact of volunteerism on both individuals and society at large.

The connection between the motivations driving individuals to engage in volunteer work and their satisfaction levels in volunteering activities, as explained by John Paul II's message on volunteerism, lies in the alignment of these motivations with the overarching themes outlined in his message.

Each of the six central themes - Compassion and Empathy, Sense of Duty, Positive Impact and Fulfillment, Personal Growth and Awareness, Interconnectedness, and Spirituality and Faith - serves as a guiding framework that resonates deeply with the intrinsic motivations of volunteers.

The underlying reasons behind volunteerism that this study was able to connect the dots between motivations and actions can be elucidated by examining the intrinsic motivations identified and how they align with John Paul II's message on volunteerism:

Compassion and Empathy: Volunteers are often motivated by a genuine desire to alleviate the suffering of others. John Paul II's emphasis on compassion resonates with individuals who are driven by empathy, reinforcing their sense of purpose and empathy towards those they serve.

Sense of Duty: Many volunteers feel a sense of duty towards their community or a higher cause. John Paul II's message underscores the importance of duty in serving others, resonating with volunteers who prioritize their responsibilities and commitments.

Positive Impact and Fulfillment: Volunteers often derive satisfaction from the

tangible impact of their actions and the fulfillment gained through service. John Paul II's message acknowledges the transformative power of volunteerism, emphasizing the positive impact it can have on both individuals and communities, thereby reinforcing volunteers' sense of fulfillment.

Personal Growth and Awareness: Engaging in service can foster personal growth and expand awareness of societal issues. John Paul II's message advocates for personal growth through service, encouraging individuals to deepen their understanding of themselves and others, resonating with volunteers seeking self-improvement and enlightenment.

Interconnectedness: Volunteers recognize the interconnectedness of all beings and are motivated by a desire to foster unity and solidarity within their communities. John Paul II's message emphasizes the interconnectedness of humanity, highlighting the importance of mutual support and cooperation, thereby reinforcing volunteers' commitment to fostering a sense of unity and belonging.

Spirituality and Faith: For some volunteers, spiritual or religious beliefs serve as a guiding force in their volunteer endeavors. John Paul II's message acknowledges the role of spirituality and faith in inspiring acts of service, providing a moral compass for volunteers and reinforcing their commitment to serving others with love and compassion.

John Paul II's message on volunteerism provides a cohesive framework that connects the dots between the motivations driving individuals to engage in volunteer work and their satisfaction levels in volunteering activities. By aligning their actions with these central themes, volunteers are able to derive greater meaning, fulfillment, and satisfaction from their service, thereby contributing to the well-being of both them and their communities.

CONCLUSION

This study reveals that volunteerism is a powerful force that fosters personal growth and benefits society as a whole. Key motivations for volunteer participation include compassion, empathy, and a sense of duty, which inspire individuals to serve and build meaningful connections within their communities. Many participants also associate their volunteer efforts with spirituality and faith, viewing them as ways to align their actions with deeper values. Personal development and increased self-esteem are common outcomes, as volunteers report feeling more confident and accomplished. The study highlights the theme of interconnectedness, showing how volunteer work contributes to a sense of collective well-being and promotes community cohesion. Volunteers express a strong commitment to making a positive impact and supporting a more inclusive world. High satisfaction rates indicate that volunteer experiences are rewarding for participants, enhancing their sense of purpose and connection to society. These findings underscore that volunteerism not only aids those in need but also enhances both individual growth and societal cohesion of those who give their time and energy, highlighting the transformative nature of altruistic engagement.
